- Selection (for individual candidates) by online entrance test at designated centres

- Email chat facility with designated mentors for each student at the Contact/Study Centre
- Network of Contact/Study Centres across India (15 Centres)
- Three component course structure including:
 - » **2** interactions at IICA Campus, Manesar, Gurgaon, Haryana (1 day each)
 - » **12 weeks** of project work with an NGO/ Foundation/Trust/Society/Section 8 company (facilitated by IICA)
 - » **3 weeks** of internship with a corporate entity (facilitated by IICA)

(Admission fee must be received by IICA by 5:00 pm, 17th September 2014. In case of non-submission of fee on time, candidature will be cancelled and seat will be allotted to next in merit list)
- **Course Commences:** 13th October 2014
- **Eligibility:**
 - » **Education:** Graduate in any discipline with minimum 50% in aggregate from a recognised university
 - » **Desirable Qualifications:** Exposure to social work projects, experience of short term courses on social interventions and effective communication skills
