# Full Time and Executive Ph.D. Management Programme (Batch 2017)

### 1. **Programmes:** Ph. D. in Management

Specialization in Finance, Operations / Decision Sciences, Economics, Human Resources and Behavioral Science, Marketing, Information Systems, Communications, Business Policy and General Management

# 2. Eligibility (For Full Time and Executive Ph. D.)

The basic qualification criteria for the purpose of admission to Ph. D. programmes shall be as under: The
degree may be conferred upon candidates in various subjects provided that for the purpose of admission and
registration they satisfy the following two conditions -

**Condition 1:** The candidate must have passed Admission Test conducted by the University.

### OR

The candidate is qualified in UGC-NET (including JRF)/UGC-CSIR NET (including JRF)/SLET/GATE examination of the apex bodies in higher/technical professional education or other equivalent examination.

Condition 2: Candidates for admission to the programme shall have a Master's degree or a professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions.

# > For Executive Ph. D.

- Executive Ph. D. will require at least 5 year Full Time Work experience in executive or supervisory capacity up to the date of written test / personal interview (out of which at least 2 years work experience should be after obtaining Master's Degree)
- The experience should be full time experience and will NOT include part time experience, internships, projects, training period, trainee (management, engineering) etc.

## Note:

- > Those candidates who have obtained their degree by doing a part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply and register as per UGC guidelines.
- For PGDM (duration of programme should not be less than 2 years) candidates are eligible to apply on submission of equivalence approval from AIU.

Full Time Ph. D. – Minimum 3 years and Maximum 4 years Executive Ph. D. – Minimum 3 years and Maximum 5 years

# 5. Online Registration and Fees

#### **Submission of Documents**

- Copy of duly filled up online application form
- Attested copies of Graduation Mark sheet and Degree Certificate (Convocation certificate)
- Attested copies of Post-Graduation Mark sheet and Degree Certificate (Convocation certificate)
- Work Experience certificate (5 years' experience) (as applicable) (If the work experience certificate is in more than one company a separate work experience certificate signed by the employer stating clearly the nature of work experience is to be submitted. The work experience certificate must contain the date of joining, designation, date of relieving (if applicable) and the level at which the designation is covered in the organization. If the current designation or the designation at the time of leaving the organization (as applicable) is/ was different than the designation at the time of joining than in such case candidate must provide the copy of the appointment letter
- Statement of Purpose (Format available on website <u>www.nmims.edu</u>). SOP should describe area of research.
- UGC-NET (including JRF)/UGC-CSIR NET (including JRF)/SLET/GATE examination or other equivalent examinations certificate (if appeared)

No Candidate will be permitted to join the Programme unless he/ she submits' the application along with SOP in time AND completes the selection process successfully.

#### 6. Selection Process:-

- NMIMS written Research Ability Test
- Critique a Research Manuscript (subject specific written test)
- Presentation based on SOP followed by Personal Interview. The candidates will have to discuss their research topic during Personal Interview (Research methodology and proposal for research).

Note: Candidates those who have qualified in UGC-NET (including JRF)/UGC-CSIR NET (including JRF)/SLET/GATE examination of the apex bodies in higher/ technical professional education or other equivalent examinations with valid score in validity period are exempted from NMIMS entrance test. However they have to appear for Personal Interview.

Final Selection will be on merit.

#### 7. Fees

Fees for 1<sup>st</sup> year Ph. D. (Batch - 2016) were Rs.71, 000/- (For Information only). The Fees Ph. D. (Batch - 2017) will be informed during personal interview.

#### 8. Refund Rules

In case an admitted student does not join the institution within 7 days of opening (Commencement of the programme i.e. 12<sup>th</sup> June 2017) of the Institution, the Institution shall refund:

1. Intimation of cancellation received at least seven days before the Course Commencement of the Programme i.e. 6 <sup>th</sup> June 2017	100% of the fees less processing charges (Rs. 10,000/-)
2. Intimation of cancellation received within six days before course commencement & up to 30 days after course commencement of the Programme from 7 <sup>th</sup> June 2017 to 12 <sup>th</sup> July 2017.	If seat is filled up by another candidate within 30 days of course commencement - 100% of the fees less processing charges (Rs.10,000/-)  If seat is not filled up by another candidate within 30 days of course commencement - 50% of the fees less processing charges (Rs.10,000/-)

Note: If a student joins the Institutions, and then leaves it in mid-session then the entire fees collected shall be forfeited.

## **Important Instructions:**

- Please note that it is responsibility of the candidate to check whether he/she is eligible to apply for the
  Program as per the eligibility criteria declared on the website. NMIMS has full right to disqualify a candidate
  at any stage of admission process if found ineligible. No separate intimation will be given. In such case, the
  admission of the candidate even if selected and fees paid stands cancelled and the fees paid will be forfeited.
