<u>Instruction Sheet – NEX MBA (NMIMS Executive MBA)- Batch 2025</u>

1. Eligibility Criteria:

- Graduation from a recognized University in any discipline with a minimum of 50% marks in the aggregate (all the subjects the candidate has taken).
- Minimum 5 years of work experience in an executive, supervisory, or managerial capacity full-time after graduation & up to the date of written test/personal interview.
- The Bachelor's Degree or equivalent qualification obtained by the candidate must entail a minimum of three years of education after completing higher secondary schooling (10+2) or equivalent.

The work experience should be full-time experience and should <u>NOT</u> include internships, projects, training periods, trainee (management, engineering) etc.

- 2. Duration of Programme: 2 Years. Weekday and weekend.
- 3. Intake capacity: 70
- 4. Online Registration and Registration Fee:
 - Online registration at www.nmims.edu
 - Before filling the online form, please read all the instructions carefully mentioned in the **Instruction Sheet** and also refer the **Important Dates**.
 - Online Registration Fee is Rs. 2,500/-
 - Registration Fee is non-refundable.
- 5. Selection Procedure:
 - Written Test
 - Personal Interview
 - Work Experience
 - Academic

The selection criteria will be based on merit only. The decision regarding the cut-off of the merit list will solely lie with NMIMS. In this regard, the decision of the NMIMS shall be final and binding on all concerned.

- 6. Fees: Rs. 4 lakhs per year; Total Rs. 8 lakhs for the Two year Programme
- 7. Please note that it is the responsibility of the candidate to check whether he/she is eligible to apply for the Program as per the eligibility criteria declared on the website. NMIMS has the full right to disqualify a candidate at any stage of the admission process if found ineligible.
