MBA (Part Time) in Social Entrepreneurship / Diploma in Social Entrepreneurship (Batch 2026)

Information Handout

- 1. Introduction:** NMIMS is committed to nurturing the social entrepreneurs of tomorrow and strengthening the social entrepreneurs of today.

MBA (Part Time) in Social Entrepreneurship is a comprehensive programme for development sector professionals who aspire to excel in an increasingly complex and competitive scenario. The programme endeavours to develop strategic orientation and motivation for success with a social conscience.

The Diploma program aims to provide managerial inputs for those who have work experience in the social development sector and to those who wish to develop their career in the social sector or who have less than two years or no work/volunteering experience.

2. Programme :

- MBA (Part Time) in Social Entrepreneurship – 2 Years
- Diploma in Social Entrepreneurship – 1 year

3. Objective of the Programme

- To provide management education to potential and current social entrepreneurs and social sector personnel to professionalize their approaches to accelerate social change.
- To help social sector practitioners and volunteers to incubate new ideas, adopt hybrid business models and spin out new social ventures.

4. Scope of the Programme

These programmes are aimed at:

- NGO Executives, Board Members of Public & Charitable Trusts, Foundations, Co-operative societies, CSR Executives and community based organisations seeking management guidance to strengthen an already established organisation.
- Executives, managers, volunteers and social sector professionals who wish to move into the management cadre by upgrading their management knowledge and skills.

- 5. Programme Structure:** The weekend Diploma in Social Entrepreneurship Programme spreads across three trimesters. MBA (Part-Time) in Social Entrepreneurship programme spreads across six trimesters and one summer term.

Blended Learning (mix of offline and online lectures)

- The programme will commence in June and the classes will be in a hybrid mode (up to 40% sessions). The class timings are- Friday evening from 6.30 pm to 9.30 pm, Saturday from 2.00 pm to 8.30 pm and Sunday from 9.00 am to 3.30 pm.

*Program will commence only if there are a minimum of 10 eligible candidates admitted after the selection process.

7. Eligibility Criteria: It is the sole responsibility of the candidate to check his/her eligibility before applying for the course.

a) For Diploma in Social Entrepreneurship

- Graduation from a recognized University in any discipline

b) For MBA (Part Time) in Social Entrepreneurship

- Graduation from a recognized University in any discipline
- Minimum two years' experience with the social sector organization (NGOs, Social Enterprises, Government Departments, CSR/ Environment/Sustainability departments) either as full time staff or as volunteers up to the date of written test / personal interview **OR** Minimum two years corporate administrative / business work experience

8. Online Registration and Registration Fee:

- Before filling out the online form, please read all the instructions carefully mentioned in the Instruction Sheet and also refer to the Important Dates.
- Online Registration Fee is Rs. 2500/- plus taxes (non-refundable).

9. Selection Procedure:

Written Test & Personal Interview will be conducted as per important dates of the programme.

Final merit list will be based on marks obtained / weightage in the entrance test & personal interview marks.

10. Fees

Fees for Batch 2025-25 – Diploma Programme - Rs. 50,000 and MBA (Part Time) Program - Rs. 3,00,000/- (for Information only)

The Fee is payable in installments and the instalment schedule will be informed later during admissions for 2026.

11. Refund of Fees in case of Withdrawal/Cancellation of Admission:

For cancellation/ withdrawal of admission: Withdrawal /cancellation means voluntary withdrawal/cancellation by a candidate for any reason. Please visit the NMIMS website for the online admission cancellation process: <https://upload.nmims.edu/admission/cancellation/> Refund rules from competent authorities will be followed.

Note:

- 1) Please note the closure of admission / last date of admission as mentioned in the important dates of the respective program
- 2) The Candidate is requested to check the commencement date. The cancellation policy/date is applicable as the refund rule clause mentions.

12. Scholarships (only applicable for MBA (Part Time) in Social Entrepreneurship)

NMIMS Scholarship : Each student based on a need cum merit basis will be eligible to apply for part scholarship from NMIMS. The scholarship amount will be decided by the screening committee, after scrutinizing each applicant. The scholarship amount will not exceed Rs. 150,000/- for MBA (Part Time) in Social Entrepreneurship students.

Mirae Asset Foundation (MAF) Scholarship: MAF provides need cum merit-based part-scholarship only for MBA (Part Time) in Social Entrepreneurship students belonging to the Economically Weaker Section (EWS). Selection of candidate and the scholarship amount will be decided by the screening committee, after scrutinizing each applicant.

13. Important Instructions:

Please note that it is the responsibility of the candidate to check whether he/she is eligible to apply for the Program as per the eligibility criteria declared on the website. NMIMS has the full right to disqualify a candidate at any stage of the admission process if found ineligible. In such case, the admission of the candidate even if selected and fees paid stands cancelled and the fees paid will be forfeited.

For cancellation/ withdrawal of admission: For cancellation/ withdrawal of admission: Withdrawal / cancellation means voluntary withdrawal / cancellation by the candidate for any reason. Candidate should visit <https://upload.nmims.edu/admission/cancellation/>.

Canvassing in any form will disqualify the candidate.

Admission to the programme is considered as “Provisional Admission” till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per the refund rule clauses even if selected/ admitted to the program

AIU certificate is mandatory for those candidates who have completed their graduation / post-graduation (Full time / Part time / Online mode) (as applicable) from overseas Universities

Please see the important dates and preserve them as a guide. All announcements from the University will be through its web site www.nmims.edu and there will be no separate email sent.

All disputes are under Mumbai jurisdiction only.

The admission information handout's eligibility requirements will serve as the only document for program eligibility. School's brochure or prospectus will only be used as a guide and not be used to refer eligibility.

If a candidate is found ineligible even after commencement of the program, he / she would be discontinued from the program and fees will be paid in accordance with standard procedure.

If at any stage of the program, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected/ admitted, will stand cancelled and fees will be refunded as per refund rule clause. Candidates' admission will be canceled by the university if they do not voluntarily withdraw
