#### **Admission Information Handout – NEX MBA (NMIMS Executive MBA)- Batch 2026**

##### **1. Eligibility Criteria:**

- Graduation from a recognized University in any discipline with a minimum of 50% marks in the aggregate (all the subjects the candidate has taken).
- **Minimum 4 years of work experience in an executive, supervisory, or managerial capacity full-time after age of 18 or graduation & up to the date of written test/personal interview.**
- The Bachelor's Degree or equivalent qualification obtained by the candidate must entail a minimum of three years of education after completing higher secondary schooling (10+2) or equivalent.

**The work experience should be full-time experience and should NOT include internships, projects, training periods, trainee (management, engineering) etc.**

It is the sole responsibility of the candidate to check his/her eligibility before applying for the course.

##### **2. Duration of Programme: 2 Years. Weekends ONLY.**

\*Program will commence only if there are a minimum of 10 eligible candidates admitted after the selection process.

##### **3. Online Registration and Registration Fee:**

- Before filling the online form, please read all the instructions carefully mentioned in the **Instruction Sheet** and also refer the **Important Dates**.

- Online Registration Fee is Rs. 2,500/-
- Registration Fee is non-refundable.

##### **4. Selection Procedure:**

Selection will be done based on Written Test - MCQ type 45 minutes to 1 hour test (Logical Reasoning, Quantitative Skills and English Language skills), Personal Interview, Work Experience, Academic.

The selection criteria will be based on merit only. The decision regarding the cut-off of the merit

list will solely lie with NMIMS. In this regard, the decision of the NMIMS shall be final and binding on all concerned.

**5. Fees:** The Fees for Batch – 2025 was **Rs. 4 lakhs per year; Total Rs. 8 lakhs for the Two year Programme.** Fees for 2026 will be declared at the time of admission in the offer letter.

**6. REFUND OF FEES IN CASE OF WITHDRAWAL / CANCELLATION OF ADMISSION:**

For cancellation/ withdrawal of admission: Withdrawal /cancellation means voluntary withdrawal/cancellation by a candidate for any reason. Please visit the NMIMS website for the online admission cancellation process: <https://upload.nmims.edu/admission/cancellation/>  
Refund rules from competent authorities will be followed.

Note:

- 1) Please note the closure of admission / last date of admission as mentioned in the important dates of the respective program
- 2) The Candidate is requested to check the commencement date. The cancellation policy/date is applicable as the refund rule clause mentions.

The AIU certificate is mandatory for those candidates who have completed their graduation/post-graduation from overseas Universities.

Canvassing, in any form for admission will disqualify the candidate.

There is NO 'Management Quota' at NMIMS for MBA Programs. If you receive any E-Mail / SMS related to it, consider it fraudulent. Beware of such activities, and do not engage in any monetary transactions.

The admission information handout's eligibility requirements will serve as the only document for program eligibility. School's brochure or prospectus will only be used as a guide and not be used to refer eligibility.

If a candidate is found ineligible even after commencement of the program, he / she would be discontinued from the program and fees will be paid in accordance with standard procedure.

If at any stage of the program, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected/ admitted, will stand cancelled and fees will be refunded as per refund rule clause. Candidates' admission will be canceled by the university if they do not voluntarily withdraw
