

VIRTUAL MUSEUM OF SECURITY MARKET





To build this and develop virtual museum, SEBI has invited Expression of Interest (EOI) from various agencies. The virtual museum will be the online platform which will display the history of the evolution of security markets in India.

RBI TO LAUNCH 'POSITIVE PAY SYSTEM' FOR CHEQUE TRUNCATION SYSTEM



The Reserve Bank of India has announced that it will launch "Positive Pay System" for Cheque Truncation System from 01st January, 2021. The "Positive Pay System" will be developed by the National Payments Corporation of India (NPCI) and make it available to participant banks. It is launched to prevent frauds with high value cheques. Under this mechanism, cheques will be processed for payment by the drawee bank based on information passed on by its customer at the time of issuance of cheque. Banks are advised to create adequate awareness among their customers on features of Positive Pay System through SMS alerts, display in branches, ATMs as well as through their website and internet banking.

ISRAEL, UAE, BAHRAIN SIGN HISTORIC US-BROKERED PEACE DEALS




In a landmark moment, Israel, UAE and Bahrain signed Abraham Accords in a signing ceremony presided over by United States President Donald Trump at the White House on September 15, 2020. The signing of Abraham Accords aims to establish foundation of peace agreements between Israel and the two Arab nations- the United Arab Emirates and Bahrain. Under the peace accord, the countries committed to the exchange of embassies and ambassadors, and to begin cooperation across a broad range of fields including education, healthcare, trade, and security. The peace accord makes UAE and Bahrain, the third and fourth Arab states respectively to take such steps to establish full relations with Israel after Egypt in 1979 and Jordan in 1994. The two gulf nations have now joined Egypt and Jordan as the only Arab nations to recognise and normalise ties with Israel.

GLOBAL HEALTHCARE FACILITIES MANAGEMENT MARKET TO REACH \$373.4 BILLION BY

2027

Amid the COVID-19 crisis, the global market for Healthcare Facilities Management estimated at US\$224.1 Billion in the year 2020, is projected to reach a revised size of US\$373.4 Billion by 2027, growing at a CAGR of 7.6% over the period 2020-2027.

INDIA-CHINA JOINT STATEMENT ON LAC: INDIA, CHINA REACH FIVE-POINT CONSENSUS AFTER JAISHANKAR-WANG MEET



The two Foreign Ministers agreed that the current situation in the border areas is not in the interest of either nation and agreed that the border troops of both nations should continue their dialogue, quickly disengage, maintain proper distance and ease tensions. India and China have reached a five-point consensus regarding the ongoing border standoff at the Line of Actual Control (LAC) after detailed talks between Indian External Affairs Minister S Jaishankar and Chinese Foreign Minister Wang Yi in Moscow on the side lines of the Shanghai Cooperation Organisation (SCO) meeting on September 10, 2020.

INTEL INTRODUCED A NEW PLATFORM AIM TO INCREASE BUSINESS



The Intel has introduced its new integrated platform built for business with built-in features for performance, security, manageability and stability known by the name Intel vPro platform. Its aim to offer business-class PC performance, hardware-enhanced security features, PC feet stability to power workforce productivity, analyse data faster, simplify connectivity and data faster.

INNOVATION HUB FOR FINANCIAL SECTOR IN INDIA—BY RBI



Reserve Bank of India has announced that it will be setting up an 'Innovation Hub' in India. The aim behind developing an innovation hub is to increase and deepen financial inclusion and promote banking services effectively and efficiently to the citizens. It will be acting as the finance-related idea creation centre. It will develop new capabilities which will create a viable and trustworthy financial and banking products and services.

RAFAEL NADAL BEATS NOVAK DJOKOVIC TO WIN 13TH FRENCH OPEN, TIES WITH FEDERER AT 20 GRAND SLAMS



Rafael Nadal has beaten Novak Djokovic 6-0, 6-2, 7-5 to win the title of the 13th French Open in tennis. With this victory on October 11, 2020, Nadal is now equal to Roger Federer's all-time record of winning 20 Grand Slams titles. The defeat in French Open for world number one Novak Djokovic has ended his hopes of winning the 18th Slam and also of becoming the first man since Rod Laver to win all the four majors twice in 1969. World Number two, Rafael Nadal improved to 100-2 at the French Open, which includes a combined 26-0 in semi-finals and finals and won his fourth consecutive title in Paris. Rafael Nadal claimed his 100th match win at the 13th French Open at Roland Garros against just 2 defeats since his debut in 2005. The 34-years old left-handed tennis player from Spain previously had put together streaks of four French Open Championships from 2005-2008. Then again five in a row from 2010-2014. The winnings went alongside his four trophies at the U.S. Open, one at the Australian Open and two at the Wimbledon.

NIHAL SARIN FROM INDIA WINS JUNIOR SPEED CHESS CHAMPIONSHIP



Young Indian Chess player Nihal Sarin has been declared as a winner in the 2020 Junior Speed Online Chess Championship of Chess.com in Chennai. In the finals, Sarin has beaten Russia's world junior No. 6 Alexey Sarana 18-7. With this win, the 16-year old Sarin has earned \$8,766 and has also become enable to qualify for the 2020 Speed Chess Championship Final which will be featuring the world's best players. The Indian teenager had beaten Australia's Anton Smirnov, American Andrew Tang, and Armenian Haik Martirosyan en route the title. Sarin had earlier lost in the first round of the 2019 Junior Speed Chess Event. Viswanathan Anand, the 5 times world Chess champion also praised Nihal Sarin on his latest achievement by stating that he is one of the world's fastest junior, and the results of the championship confirm it. Nihal Sarin is also a former world Under-10 champion. Sarin has now joined the Indian men's team that has been taking past in the Asian Online Nations (Regions) Cup Team Championship which began on October 10, 2020


NO NEED TO CARRY DRIVING LICENSE AND RC: NEW MOTOR VEHICLE RULES FROM OCTOBER 1

A number of new motor vehicle rules are set to come into force from October 1. These new rules which have been put into force with the aim of ensuring convenience of commuters, have been notified by the Union ministry of road transport and highways. MoRTH (Ministry of Road Transport and Highways) has issued notifications regarding the amendments in the Central Motor Vehicles Rules 1989, requiring implementation of the enforcement, maintenance of Vehicular Documents and E-Challans through the portal with effect from 1st October 2020, in order to monitor and enforce the MV Rules in better ways. MoRTH, in a statement said that the use of IT services and electronic monitoring will result in the better enforcement of (traffic) rules in India, and will also lead to reduction/removal of harassment of drivers (while also facilitating the citizens)

FARM BILL 2020

There has been a commotion after the Parliament passed three agriculture related bills. The three bills that were passed are the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Bill, Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Bill and Essential Commodities (Amendment) Bill. The government said that the bills would change the agriculture part. It would likewise raise the farmers' pay, the Centre said. Further the government had additionally guaranteed twofold farmers' salary by 2022 and the Center said that the Bills will make the farmer autonomous of government-controlled business sectors and bring them a superior price for their produce. The Bills propose to make a framework wherein the farmers and traders can sell their produce outside the Mandis. Further, it energizes intra-state trade and this proposes to lessen the expense of transportation.

Moreover, the Bill figures a structure on the arrangements that empower farmers to draw in with agribusiness organizations, retailers, exporters for administration, and offer of produce while giving the farmer admittance to current innovation. It additionally gives advantages to the little and peripheral farmers with under five hectares of land. The Bill additionally will eliminate things, for example, cereals and pulses structure the rundown of basic wares and draw in FDI. However, the farmers have been uncertain about this Bill as they feel the bill would put them at a disadvantage. They state that they are troubled about getting Minimum Support Price for their produce. They are additionally worried about the advantage of the agri-organizations and large retailers in dealings. They likewise state that the organizations may direct the price and the advantages for little farmers may lessen the commitment of backers with them.



CORPORATE ENGAGEMENTS COMMITTEE



A webinar was held by the Corporate Engagement Committee, Lei Ipsum, on 14th October 2020 on the topic-"How leadership impacted the foreign policies post-independence." Th e speaker Achal Malhotra is a former Ambassador of India to Armenia and Georgia and a retired Indian Foreign Service officer. He is an eminent personality who gave his insight on the topic. The webinar helped the students in understanding leadership impacts various aspects of life and they also learnt how they could utilise the skills of leadership in the corporate world. 
LITERARY & DEBATING SOCIETY


