MBA (LAW) AT SBM, NMIMS MUMBAI


The School of Business Management (SBM) of the SVKM's NMIMS Deemed to be University is a leading business school in India located in the heart of the finance capital city, Mumbai.

Currently this MBA Program is in its fifth year and has successfully delivered three batches of students to the corporate world.



The objective questions will be on the following areas:


- Logical Reasoning: 25 Marks

- Successful candidates passing through this process are admitted into the MBA (Law) Program.










SECTOR WISE STUDENT PLACEMENTS




SECTOR WISE COMPANIES VISITING CAMPUS


