(1)	100%	15 days or more before the formally-notified last date of admission (on or before 8 <sup>th</sup> June 2020)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (i.e. from 9 <sup>th</sup> June 2020 to 24 <sup>th</sup> June 2020)
(3)	80%	15 days or less after the formally-notified last date of admission (i.e. from 25 <sup>th</sup> June 2020 to 9 <sup>th</sup> July 2020)
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (i.e. 10 <sup>th</sup> July 2020 to 24 <sup>th</sup> July 2020)
(5)	00%	More than 30 days after formally-notified last date of admission (i.e. from 25 <sup>th</sup> July, 2020 onwards)

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.

(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (12 <sup>th</sup> July 2020 to 26 <sup>th</sup> July 2020)
(5)	00%	More than 30 days after formally-notified last date of admission (27 <sup>th</sup> July 2020 onwards)
