Refund Rules: If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees* remitted by the student.

| Sr. No. | Percentage of Refund of Fees* | Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI) |
|----------------|--------------------------------------|--|
| (1) | 100% | 15 days or more before the formally-notified last date of admission (on or before 3rd August 2020) |
| (2) | 90% | Less than 15 days before the formally-notified last date of admission (4th August 2020 to 19th August 2020) |
| (3) | 80% | 15 days or less after the formally-notified last date of admission (20th August 2020 to 3rd September 2020) |
| (4) | 50% | 30 days or less, but more than 15 days, after formally-notified last date of admission (4th September 2020 to 18th September 2020) |
| (5) | 00% | More than 30 days after formally-notified last date of admission (19th September 2020 onwards) |

***For Payment of Fees Sundays and Holidays Excluded**

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.

Note: Candidates to refer Important Dates of the respective programme.

The above refund rules are as per University Grants Commission (UGC) notification on Refund of Fees and Non-Retention of Original Certificates of October, 2018 and are subject to revision as per UGC notification (as applicable). Please note the closure of admission/last date of admission as mentioned in the refund is Wednesday, 19th August, 2020.
