Refund Rules: If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees* remitted by the student.

Sr. No.	Percentage of Refund of Fees*	Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI)	
(1)	100%	15 days or more before the formally-notified last date of admission	
(2)	90%	Less than 15 days before the formally-notified last date of admission	
(3)	80%	15 days or less after the formally-notified last date of admission	
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission	
(5)	00%	More than 30 days after formally-notified last date of admission

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.

Instruction Sheet - MBA (Law) Program - Batch 2021

1. Eligibility Criteria:

- The candidate should have passed in the examination conducted by a recognized University leading to award of LL.B. /B.A. LLB /B.B.A. LLB /B.Sc LL.B ./LL.M. degree (minimum 50% in final year examination or aggregate in all years). Candidates who have appeared for the final year examinations may also apply. Their initial admission, if selected, will be provisional and will be confirmed after submission of the final year/semester/trimester mark sheet and fulfilling the eligibility criteria for final percentage/marks.
- Candidates who have duly passed the final examination conducted by the Institute of Chartered Accountants of India, the Institute of Cost Accountants of India or the Institute of Company Secretaries of India (Any one)
- Candidates who have cleared their graduation by doing part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply and register as per UGC guidelines.
- 2. Duration: 2 years
- 3. In take capacity: 40 Students

- Online Registration Fees is Rs. 2,000/- plus taxes (This is one time fee, no fees will be charged for Personal Interview)
- Registration Fees are non-refundable.

5. Payment of Registration Fees:

Payment of registration fees can be made by credit card (visa/ master).

6. Selection Procedure:

- Written Test conducted for MBA (Law) Program by NMIMS
 OR
- Candidates with GMAT score of 600 and above (GMAT score of last 3 years will be considered) OR
- Candidates with score of 200 & above in NMAT by GMAC for 2021 admissions AND
- Personal Interview

7. Written Test and Personal Interview Process

Written Test and Personal Interview will be conducted online, refer important dates on website (<u>www.nmims.edu</u>). Kindly refer to the sample question paper uploaded on website.

8. Fees

The Fees for MBA (Law) Program for the 2020-21 Batch were Rs. 14,03,000/- for two years (First year fees Rs.7,02,000/- & Second year fees Rs.7,01,000/-). Payment for each year to be made on or before due date which will be intimated by admission department. The fees for the 2021-23 Batch will be informed during written test / personal interview.

NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible.
