Refund Rules: If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees* remitted by the student.

Sr. No.	Percentage of Refund of Fees*	Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI)
(1)	100%	15 days or more before the formally-notified last date of admission
(2)	90%	Less than 15 days before the formally-notified last date of admission
(3)	80%	15 days or less after the formally-notified last date of admission
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission
(5)	00%	More than 30 days after formally-notified last date of admission

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.

Note: Candidates to refer Important Dates of the respective programme.

The above refund rules are as per University Grants Commission (UGC) notification on Refund of Fees and Non-Retention of Original Certificates of October, 2018 and are subject to revision as per UGC notification (as applicable).

1. Eligibility Criteria:

- a) For Diploma in Social Entrepreneurship
- Graduation from a recognized University in any discipline
- b) For MBA (Part Time) in Social Entrepreneurship
- Graduation from a recognized University in any discipline
 - Minimum two years' experience with the social sector organization (NGOs, Social Enterprises, Government Departments, CSR/ Environment/Sustainability departments) either as full time staff or as volunteers up to the date of written test / personal interview **OR** Minimum two years corporate / administrative / business work experience

2. Duration of the Programme :

- MBA (Part Time) in Social Entrepreneurship – 2 Years
- Diploma in Social Entrepreneurship – 1 year

3. In take Capacity

- MBA (Part Time) in Social Entrepreneurship – 30
- Diploma in Social Entrepreneurship – 30

4. Online Registration and Registration Fee:

- Before filling the online form, please read all the instructions carefully mentioned in the Instruction Sheet and also refer the Important Dates.
- Online Registration Fee is Rs. 1,000/- plus taxes (non-refundable). Payment of registration fee can be made by Credit Card (Visa/ Master).

5. Selection Procedure:

Written test & Personal Interview will be conducted online as per important dates of the programme.

6. Fees

Fees for Batch 2020 – Diploma Programme - Rs. 28,000/- (including Rs. 1,000/- library deposit) and MBA (Part Time) Program - Rs. 1,03,000/- (including Rs. 1,000/- library deposit) (for Information only) (Payable in Instalments). The Fees for Batch - 2021 will be informed during personal interview.

7. Please note that it is responsibility of the candidate to check whether he/she is eligible to apply for the Program as per the eligibility criteria declared on the website. NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. In such case, the admission of the candidate even if selected and fees paid stands cancelled and the fees paid will be forfeited.

8. For cancellation/ withdrawal of admission: Withdrawal /cancellation means voluntary withdrawal/cancellation by candidate for any reason. Candidate should email at

admissioncancellation@nmims.edu, the soft copy of admission cancellation form duly filled and signed (available on www.nmims.edu (<https://www.nmims.edu/students/>), fee paid receipt copy & cancelled cheque (personal account).
