1. Eligibility Criteria:

- Graduation from a recognized University in any discipline.
- Minimum 2 years work experience in executive or supervisory capacity after completion of graduation & up to the date of written test/personal interview.

Those candidates who have obtained their degree by doing a part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply and register as per UGC guidelines.

The work experience should be full time experience and should \underline{NOT} include internships, projects, training period, trainee (management, engineering) etc.

7. Submission of Documents

Please upload below mentioned list of document using the link given in registration form before the last date of registration. It is important and primary requirement to have the mandatory documents to process the call letter for Entrance test.

- Degree mark sheet for all years & Degree Certificate (Convocation Certificate).
- Work Experience Certificate (showing experience of 2 years or more), Appointment letter, promotion letter and relieving letter.

(If the work experience certificate is in more than one company a separate work experience certificate signed by the employer stating clearly the nature of work experience, tenure, designation is to be submitted.)

- **8. Written Test & Personal Interview:** Written test & Personal Interview will be conducted as per important dates of the programme.
- **9. Fees:** The fees for MBA (Part Time) Batch 2019 was Rs. 6,01,500/- (payable in instalments) (for Information only). The Fees for Batch 2020 will be informed during personal interview.
- 10. Please note that it is responsibility of the candidate to check whether he/she is eligible to apply for the Program as per the eligibility criteria declared on the website. NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. In such case, the admission of the candidate even if selected and fees paid stands cancelled and the fees paid will be forfeited.
