### 1. Eligibility Criteria:

- Graduation from a recognized University in any discipline.
- Minimum 2 years work experience in executive or supervisory capacity up to the date of written test/personal interview.

Those candidates who have obtained their degree by doing a part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply and register as per UGC guidelines.

The work experience should be full time experience and should <u>NOT</u> include internships, projects, training period, trainee (management, engineering) etc.

## 4. Online Registration and Registration Fee:

- Online Registration Fee is Rs. 1,700/- (This is one time fee, no fees will be charged for Personal Interview)

### **6.** Selection Procedure:

• Written Test conducted for MBA (Part Time) by NMIMS.

• Candidates with GMAT score of 600 and above (GMAT score of last 3 years up to the closure of registartions will be considered)

- Candidates with score of 200 and above in NMAT by GMAC examinations for 2019 admission AND
- Personal Interview
